Reminder - FDA Food Safety Modernization Act (FSMA) --- **Important Dates extended**

FDA has extended the comment period on several proposed rules. See the summary of dates below.

| Proposed Rule | Comments Due By |

| Foreign Supplier Verification Programs (FSVPs) | January 27, 2014 |
| Accreditation of Third-Party Auditors/Certification Bodies | January 27, 2014 |
| Preventive Controls for Animal Food | February 26, 2014* |
