MEPs call for tougher measures to fix food fraud --- MEPs have called for extra measures to tackle food fraud following last year's horse meat crisis, in a non-legislative resolution passed on Tuesday. The European Parliament agreed that the lack of harmonisation across the European Union made it difficult to prevent and police food fraud risks on an EU-wide basis.

Esther De Lange's report was approved by 659 votes to 24, with 8 abstentions. It calls for a harmonised definition of food fraud, and stronger authority for the EU Food and Veterinary
