	<p>2) Any substance or combination of substances presented for treating or preventing disease in animals, which may be administered to animals with a view of making a medical diagnosis or of restoring, correcting or modifying physiological functions in animals (e.g. Veterinary medicinal products as defined in Article 1 of Council Directive 2001/82/EC on the Community code relating to veterinary medicinal products), are not covered within the scope, with the exception of coccidiostats and histomonostats used as, for example, feed additives in the EU.</p>
