SUBJECT	<u>COMMISSION IMPLEMENTING REGULATION (EU) 2019/901</u> : the authorisation of riboflavin produced by Ashbya gossypii (DSM 23096), riboflavin produced by Bacillus subtilis (DSM 17339 and/or DSM 23984) and riboflavin 5'-phosphate sodium salt produced by Bacillus subtilis (DSM 17339 and/or DSM 23984) (sources of vitamin B2) as feed additives for all animal species.

PURPOSE	The purpose of this Certification Instruction is to describe the actions that Certification Bodies shall take following the Implementation of REGULATION (EU) 2019/901 as of 29 May 2019

CERTIFICATION INSTRUCTION	As of 2019-06-23 and within the EU market, there are three different riboflavins from microorganisms (Ashbya gossypii DSM 23096, Bacillus subtilis DSM 17339 and/or DSM 23984, Bacillus subtilis DSM 17339 and/or DSM 23984) which are authorized as feed additives for all animal species.
	Certification Bodies shall identify all the FAMI-QS Certified Feed Business Operators (producers and traders) that have Vitamin B2 under their scope of certification and ensure that the conditions of the regulation (EU) 2019/901 of 29 May 2019 for placing in the EU market are fulfilled.
	Special attention shall also be given to producers and traders of premixtures, dietetic feed and complementary feed, that may use Vitamin B2.
	Certification Bodies shall inform their auditors accordingly in order to design the appropriate focus area during their audits to the FAMI-QS Certified Feed Business Operators.

Audit reports without a confirmation statement that the conditions of REGULATION (EU) 2019/901 of 29 May 2019 were fulfilled, will not be validated.
Clarification: the regulation (EU) 2019/901 of 29 May 2019 is exclusively for placing in the EU Market. Vitamin B2 produced with other strains than the ones listed in the regulation will still be covered under FAMI-QS for non-EU countries.
