SUBJECT	ISO 22000:2018 Amendment 1: Climate Action Changes – Requirements
PURPOSE	To add Climate Change Consideration to FAMI-QS Code Version 6.0.
	ISO requires organizations to consider the effect of Climate Change on achieving the intended results of a management system. As a result, two additional statements have been added to an amendment to the existing suite of ISO management system standards. These statements were published on February 2024, in the ISO 22000:2018 Amendment 1: Climate Action Changes. In alignment with the Amendment, the following statements (in bold and italics) are added to FAMI-QS Code Version 6: 4.1 Understanding the organization and its context.
Certification Instruction	The Operator must determine the external and internal risks that are relevant to its purpose and its strategic direction and that affect its ability to achieve the intended result(s) of its Feed Safety and Quality Management System. The Operator must monitor, review and record the information about these external and internal risks. Added: The Operator shall determine whether climate change is a relevant issue that could affect the Management System to achieve is intended result. 4.2 Understanding the needs and expectations of interested parties.

	f. When interested parties of the FAMI-QS certified Organization have requirements regarding climate change, this has to be reflected in the management system.
Clarification	The object of conformity assessment remains the Feed Safety and Quality Management System and it is not affected by the two additional statements. As already provided in the current text of FAMI-QS code 4.1 Understanding the organization and its context, "The Operator must determine the external and internal risks that are relevant to its purpose and its strategic direction and that affect its ability to achieve the intended result(s) of its Feed Safety and Quality Management System". With the two additional statements we ensure that climate change is not understated.
Compliance	FAMI-QS Certified Feed Business Operators shall meet the requirements of this Certification Instruction immediately. Certification Bodies shall audit the implementation of the climate change requirements in the next subsequent audit. In the event that there is no action taken on these provisions, a major NCR shall be raised against this Certification Instruction.
